

2018 MEXICO Dream Vacation Raffle - Official Rules and Regulations

The Mexico “Siesta After the Fiesta” Dream Vacation Raffle (“Raffle”) is being conducted by NAMI DuPage (“Sponsor”), a not-for-profit charitable organization, to raise funds for ongoing charitable purposes. The Official Rules and Regulations (the “Official Rules”) are set forth below. By purchasing a Raffle ticket (a “Ticket”), the purchaser acknowledges that he or she (a) agrees to be bound by the Official Rules, (b) that the decisions of the judges are final on all matters relating to the Raffle, (c) releases the Sponsor and its agents and their respective parent companies, subsidiaries and affiliates, and each of their respective officers, directors, employees and agents from any and all liability, loss, or damage arising out of their participation in the Raffle or with respect to the awarding, receipt, possession, use and/or misuse of any prize. Sponsor reserves the right to cancel the Raffle or change any element thereof, with or without notice, at any time, due to printing errors or other mistakes in the production of the Raffle.

Eligibility

Any individual who is 21 years of age or older at the time of the purchase of the Ticket is eligible to enter the Raffle.

How to Enter

Tickets are \$100.00 per ticket. The following discounts are provided for multiple tickets purchased at the same time: Two (2) tickets for \$150.00. Only one (1) eligible person may be entered in the Raffle per Ticket sold. If the name of more than one (1) person is provided on a Ticket entry form and that Ticket is selected as a winning ticket, then the person named first will be deemed as the holder of record of that Ticket and declared the winner.

Only 100 Tickets will be sold. Tickets will be sold until the drawing on May 5th, 2018, but may sell out before that time. An individual can purchase as many Tickets as he or she may wish, subject to availability.

Tickets may be purchased

By the Internet at www.namidupage.org. Follow the instructions to complete the order form and submit payment. NAMI DuPage reserves the right to reject any entry form that is submitted without proper payment or payment that does not constitute “good funds.” No refunds will be made.

Upon receipt and acceptance by NAMI DuPage of a proper entry form, a receipt (ticket stub) of purchase will be sent to the purchaser at the billing address provided or the email address provided by the purchaser during the Ticket purchase. It is the purchaser’s responsibility to provide a valid, deliverable mailing or email address to NAMI DuPage.

Prize Drawing

The prize drawing will be held on May 5, 2018 at the Shine a Light Gala at the Naperville Marriott Hotel and be conducted by a representative of NAMI DuPage. The drawing is open to the public. Entrants need not be present to win. The raffle winner will be selected at random.

Prizes

Subject to availability and the terms and conditions of these Official Rules, prizes are listed below. The chosen Raffle Winner will be awarded the choice of **ONE** the following raffle prizes*:

TERMS AND CONDITIONS

The Raffle Winner will directly coordinate prize delivery with Winspire, the raffle prize consignment provider. Winners of travel related prizes must comply with all applicable requirements and restrictions related to said prizes including, without limitation, applicable travel dates, travel documentation and reservation and confirmation procedures.

For any vacation packages chosen as the prize, the Raffle Winner assumes all fees, local, state and federal taxes (including, but not limited to, income taxes based on the value of the prize, any other taxes).

Vacation Package Alterations

Winspire, the raffle consignment provider, operates as a full-service travel agency and can assist with additional hotel nights, airfare upgrades, or adding extra people to your vacation package. In addition, Winspire's Concierge Service provides an established network of onsite contacts for the vacation package who can help book additional excursions, activities and sightseeing tours.

Notification of Winner

The Raffle Winner will be notified according to the contact information provided to NAMI DuPage at the time of Ticket purchase. If the Raffle Winner cannot be located by 5:00 p.m. on June 1, 2018, after reasonable attempts to make contact through the information provided at the time of purchasing the Ticket, such winner will be deemed to have donated their prize to NAMI DuPage.

Redemption of Vacation Package

The Raffle Winner will receive a Booking Voucher within 1 week of receiving payment from NAMI DuPage. Once the Raffle Winner receives their Booking Voucher, they can immediately begin the redemption process.

Winning Odds

The odds of winning a prize will depend on the number of tickets sold. If all 100 tickets are sold the odds of winning the prize is 1 in 100.

Non-Deductibility of Ticket Purchase

The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently, the purchase of a Ticket does not qualify as a deductible charitable contribution.

Taxes

There may be federal, state and/or local tax consequences of winning a prize in this Raffle. Any and all taxes are the sole responsibility of the winner. Each purchaser of Tickets is advised to consult his or her own tax advisors with respect to tax liabilities that may arise from winning a prize in this Raffle

Terms and Conditions

The Raffle is subject to these Official Rules. By entering this Raffle, entrants accept and agree: (1) to be bound by these Official Rules and the decisions of NAMI DuPage which shall be final and binding; (2) waive any right to claim ambiguity in the Raffle or these Official Rules; and (3) that NAMI DuPage may use the entrant's name, photograph, statements, and city of habitation for promotional or advertising purposes in connection with the Raffle in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation, except where prohibited by law. Cancellation/Termination of Raffle

By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that NAMI DuPage has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason, and in such event, a participant's sole and exclusive remedy shall be to receive a refund of the full price paid by such participant for each Ticket purchased, without interest.

The Mexico Dream Vacation raffle assumes a minimum of 60 tickets are sold. If less than 60 tickets are sold, then the Prize will be reduced as described below:

If fewer than 60 Tickets are sold by the ticket sale deadline, the Raffle will be held as scheduled, except that the Prize winner will receive a cash prize equal to 50% of the total Ticket proceeds received by NAMI DuPage. For example, if 60 tickets are sold and the total gross proceeds of tickets is \$4,500, the winner would receive a grand prize of \$2,250, or 50% of raffle proceeds (total tickets sold does not necessarily equal gross proceeds due to multi-ticket discount).
